MINUTES**PRESENT:** John, Rick T, Rick C., Kathie N., Liv, Kathy J., Steve, Ted S, Nancy, Bob W.**Guest:** Dan Berg

The meeting was called to order at 5:02 p.m.

**Welcome/Agenda Additions: SIBS, Respect for Law, Culvers Update, STOC grants, Lussier Christmas Party & National Mustard Day.** SIBS event happening in September is uncertain. Respect for Law: John is awaiting a reply from the Police Department. Culvers Update: potentially September 22. STOC grants: Rick T. will manage the requests and board presentation Lussier Christmas: Rick C. reported that the party is not a certainty due to COVID and at this time, Walmart has denied the request to donate but the store manager is pursuing it through his supervisor. International Mustard Day: Bob reported the Virtual International Mustard Day will be held virtually on August 1.

**Approval of Minutes from 6/9/2020:** Bob W moved & Steve seconded to approve; passed unanimously.

**Financial Reports:** there were only 5 financials transactions in June! \$5400 in checking; 2 members' dues are outstanding. Operating Account - Payable to OI for registrations fees for June OI virtual conference - 2 @ \$25 & 2 @ \$35. Not in operating budget but perhaps covered by SWIS Conference line item. Bratfest earned \$247. Youth Foundation A/C - Donations received from STOC members through June billing collections of \$60. Value of Vanguard investments increased \$51 in June. Christmas party has \$684 and SIBS program \$2450 in bank.

We started the fiscal year with 40 members. After adding Jane Meyer in February 2020, & adding & losing Joe Herr this year, STOC remains at 41 members. Liv moved and Nancy seconded to accept the financial reports.

**Bucky Books:** Dan Berg reported that there will be an option to get a hard copy book and/or an online platform where books will be shipped to the customer. STOC will provide a logo and John will write a summary of our activities.

**Kwik Trip-Kathy Johnson:** she reported that the charitable earnings would be meager (e.g., \$5 on a \$100 gift card purchased by a member with \$0 return on gasoline purchases and 5% on in-store purchases), so she and Bob recommend that we not participate in the Kwik Trip Scrips Program.

**Happy Dollars:** \$1,126 (per 7/1) + \$47 + \$46 = \$1,219 total

**Football CRZR Fundraiser:** 19 sold/\$220 paid/\$160 due = \$380 Total

**Program Update:** we have guest Speakers through August 19.

**20/21 Officers/Newsletter:** Kathie Newman has accepted the position of President and John Fons will assume responsibility from Liv for the newsletter.

**Culvers Update:** Rick C. reported that he is working with management for a September 22 date, if possible.

**Adjourn to August 11, 2020 via Zoom.** at 5:45 Bob motioned; Liv seconded to adjourn; passed unanimously.

**5:45 p.m. Foundation Board Meeting Called to Order:** Scholarship Award Deferments. \$17,800 in bank. Request for \$1000 scholarship deferment until 2021 due to COVID motioned by Rick T, seconded by Kathy J to defer her scholarship until 2021. Steve motioned and Nancy seconded to adjourn. Adjourned at 5:55 p.m.

**MINUTES**

**PRESENT:** John, Rick T, Rick C., Kathie N., Kathy J., Nancy, Bob W. **ABSENT:** Liv, Steve, Ted S.  
The meeting was called to order at 5:09 p.m.

1. **Welcome/Agenda Additions: \$16 Zoom subscription:** is being paid by John as a club contribution but for the 2020-21 fiscal year, this will be included in the STOC budget and paid by the club. **Annual Golf Outing:** Bob will explore if members would be interested in playing on a Saturday in September. **Lussier Christmas Party:** Rick C. reported that due to COVID, the party will very likely be canceled. Sept. Culvers is canceled.
2. **Approval of Minutes from 7/12/20:** tabled until September meeting
3. **Financial Reports:** operating cash balance is \$5,987 and is expected to remain about there through 9/30/20 end of fiscal year. This is about \$1,500 higher than normal year-end - will consider transferring some to Foundation in September. Vanguard investment is up 22% overall over past two years. Virtual Bratfest earned STOC \$247! 2020 Scholarships are all paid. Operating net income currently is \$1,830 vs 2020 budget of \$600 loss. This is due to \$700 budgeted for year-end annual banquet (canceled) and related expenses, only \$90 in guest meals this year, speaker and plaque expenses way down from budget, STOC ahead almost in meal revenues and net expenses due to billings with Radisson, new members dues \$100 over budget and savings of about \$200 with two SWIS conferences cancelled. Amount available for grants should be about the same as last year's \$5,900. Membership still at 41. Kathy J. motioned to accept reports and Kathy N seconded. Unanimous approval.
4. **ISADEx Invoice:** STOC website started on 8/1 a few years ago, which does not coincide with our fiscal year. We are billed \$35 for domain name and \$360 for annual web services. Last year we waited until the new fiscal year to pay and got cut off for a few days! Bob renegotiated the annual service to an October 1 start but not the domain name. Bob motioned & Rick seconded to pay the \$35 fee now – Approved.
5. **Grant Application Review/Edit:** this year's edit includes how applicant heard about the grant. Apps due 9/5. Rick will submit it for the August newsletter and John will send out by e-mail. Rick to let Board know of progress by August 31.
6. **Annual Banquet/Silent Auction:** due to COVID, the silent auction and banquet will not be held.
7. **News from Optimist International: Dues; Social Media; HQ:** No increase in dues for 20/21. They created a social media policy to follow.
8. **Nomination/Election of Sauk Trails Officers and Board Members:** officers and board members will be installed by Zoom during a noon meeting – need 14 members for a quorum. We need a vice president and have two two-year and one one-year positions to fill. Rick C. will continue. Steve and Liv's terms are up. The plan is to present the slate to the membership for a vote on August 19.
9. **2020 Super Optimist Sibs Day Postponement from September 26:** being postponed due to COVID.
10. **Respect for Law August 26 – Communication with MPD-Honorees:** John received an email from the West District Captain, Tim Patton, saying he has selected police officers Joseph Buccellato and Daniel Sherrick. Each will name a charity for the STOC \$100 donation. Acting Chief Wahl and perhaps a commander also could be attending. John has invited guests from Zone 7 and the OI President to attend.
11. **Football CRZR Fundraiser: 51 sold/19 remaining-STOC portion \$600. Happy Dollars: \$1484 to date**

**Adjourn to September 8, 2020 via Zoom.** at 6:07 motioned by Kathy J ; seconded by Nancy to adjourn; passed unanimously.

We were then at Babe's from 2002 until 2010. They decided we didn't have a big enough group to use their meeting room every week. For a year and a half starting in March, 2010 we enjoyed excellent food at Sprechers. Unfortunately, they didn't have a meeting room which was large enough for us to grow.

Then in October, 2011, with Jacci as new club President, lunches became very interesting. We were at the Vintage for three months, then Claddaugh for two weeks (they didn't have a private room for us), Denny's for two weeks (Steve's all-time favorite!), and almost met at Bella Vita (the old TGI Fridays on Gammon Road), but they permanently closed the day before we were scheduled for lunch!

We have been enjoying lunches at the Radisson ever since, starting in February, 2012.

When we started in 1992, the weekly charge for lunch was \$6! It stayed at \$6 until 1999 but has been going up steadily over the next twenty years to our present level of \$15.
