The meeting was called to order by Mary Schwartz at 7:55 AM. A motion was made by Carole, seconded by Diane and passed, to approve the minutes of the June 12, 2013 Board Meeting.

<u>Treasurer's Report:</u> Bob asked for questions regarding the June, 2013 financial statements. STOC had an operating cash balance of \$3,885 as of June 30 and Foundation cash and investment balances totaled \$13,336. The Board discussed one outstanding account receivable balance – Jacci will be asked to follow-up on this. A motion was made by Rick, seconded by Dan and passed, to accept the June, 2013 Treasurer's Report.

<u>Membership Report:</u> The next evening happy hour membership event will be on August 14 and will replace that week's lunch meeting. There will be a \$5 charge to members only for this event which will be billed in October. STOC's membership remains at 40 regular members plus 6 FOO's for a total of 46 members. The September 30, 2012 numbers were 41 regular members plus 5 FOO's also for a total of 46.

<u>Speaker Schedule</u>: Our July 17 meeting speaker, Mary Anne Brown, has invited several friends to attend our lunch meeting and listen to her presentation – they will be paying for their own meals.

<u>Service/Volunteer Committee</u>: The June Monday at Reach-a-Child event went well with approximately 8 members attending and working and then going to Monk's afterward. Volunteers prepared handwritten postcards which were sent to potential corporate sponsors. Excessive heat is an issue during the summer months at their warehouse.

The Board discussed other service projects which STOC members could participate in. Carole will bring a list of JOOI projects planned for the coming school year for discussion at a future STOC Board meeting. Rick and Carol noted that there are currently six JOOI committees with each of our three advisors leading two. More STOC members could be involved to cut down on the number of committees per advisor. This will be brought up at future lunch meetings.

<u>Summer Pool Party</u>: The STOC summer party remains on track for the evening of July 18 at Jacci and Ted's home. This will be a potluck except for the main course. Following discussion, a motion was made by Carole, seconded by Rick, and passed, to increase the 2012-2013 operating budget for this line item from \$100 to \$150.

<u>Finance/Fundraising Committee</u>: It was noted that the W club did not get this year's contract to handle UW concessions. It is not yet known if the new vendor will be using local clubs. Concession stand revenues accounted for over 25% of our 2012-2013 fundraising.

Mary will send letters to STOC members by September reminding them of the importance of donations to our Foundation.

<u>Social/Membership Committee:</u> The Committee members met with Mary to discuss approaches to attracting younger members to STOC. Various approaches were discussed including using Craig's List (came out of the February, 2013 SWIS Conference). This topic will be a discussion item at an upcoming lunch meeting.

<u>STOC Calendar</u>: The next STOC Board meeting is scheduled for 7:45 on August 15. The September Board meeting will be held on <u>September 11</u> at 5:30 at Basie's and the October Board meeting is scheduled for October 15 at 7:45 AM. The STOC annual banquet is scheduled for September 25.

The meeting was adjourned at 9:00 AM.
