**Well this year's Lussier Christmas Party was one of most successful ever and based upon my total experience coordinating it, the need was greater than perhaps ever. FRANK RATH**

1. We had a pretty big turn out and there were a plethora of happy, smiling faces at the party – both the attendees and the volunteers. We are going to schedule a recap meeting with the team from Lussier and I will get a better idea of what the total number of participants were.
2. The food was great and plentiful (a special shout out to Patti). Left overs served a good purpose as what was already out for serving went to attendees and a few Optimist members and what had not yet been placed out on the buffet was packaged up and placed in the Center's food pantry for community members to pick up the following day.
3. We had approximately 40 extra gifts. The Center's interim director asked if we needed to return them or if he could utilize them. Two other smaller community centers in the Madison area have annual Christmas gift programs for their constituents and those centers had lost their donors' support for those programs. He asked if it would be OK to give the extra presents to those centers and of course we were very happy to oblige.
4. The Memorial High Students/Spartan Youth Optimist club volunteers were once again great! What an inspiration – seeing our often maligned youth doing good in their community.
5. Although we were not successful in securing a “grant” to support the entire party we did receive two monetary contributions – one from the One Community Bank in Middleton and one from the Walmart in Jefferson, WI (thanks to my daughter Laura's efforts). The Foundation donated \$1,200 and STOC members stepped up and made up the difference! Thanks much to all of them. The total cost for the party was \$2,400 rounded up.
